<p>* As at 12 July 2022, Brickell holds an aggregate total of 47,953,868 ordinary shares, representing 12.71% of the voting rights attributable to all of the ordinary shares then in issue in R&Q. This is broken down as follows:</p> <ul style="list-style-type: none"> • 11.02% held by Brickell PC Insurance Holdings LLC; and • 1.69% held by Brickell Insurance Holdings LLC.

However, as certain US jurisdictional regulatory consents / approvals remain outstanding, the ability for Brickell and its affiliates (which in certain jurisdictions, including certain states in the United States of America, includes 777 Partners LLC) to exercise voting rights attached to any shares over 9.9% continues to be restricted until such time as the appropriate consents or approvals have been obtained.

[For completeness, we note that 777 Partners LLC holds 5,379,065 shares in R&Q which represents 1.43% of the issued share capital in R&Q as at 13 July 2022.]
